Proposal

The purpose of this proposal is two-fold:

- 1) Request revision of the current academy name from B.E.A.C.O.N (Broadcast Engineering and Communication Networking) Academy to Beacon Academy of Media and Digital Arts
- 2) Request acceptance of the revised Beacon Academy of Media and Digital Arts curriculum to align with requirements and characteristics of a magnet program.
 - honors-level program
 - eligibility to obtain college credit (AP courses and articulated credit) AP Capstone certificate or diploma designation
 - industry recognized Adobe Premier Pro certification credential prior to graduating.

Rationale

- Since its inception in 2009, the Beacon Academy has integrated elements of the career academy model including smaller learning community (SLC) design, sequential courses, and a career theme into its structure.
- Beacon Academy courses were developed as CTE courses utilizing state course codes that made them eligible for federal and state funding.

Program Uniqueness

Program Uniqueness

- The AP Capstone an innovative diploma program from the College board that equips students with advanced level research, teamwork and communication skills.
- ▶ AP Capstone program requires successful completion of two courses: AP Research and AP Seminar.

Career Pathway/Program of Study Implementation Cost

In collaboration with the departments of Information Services; Plant Operations; and Career Technical Education an internal analysis was done to determine the feasibility of restructuring the Beacon Academy. The findings revealed that implementation of the proposed career pathway will incur costs in relation to equipment, professional development and supply purchases; Carl D. Perkins and Career and Technical Education Improvement grants will be used to support the previously stated purchases.

Career Pathway/Program of Study Implementation Cost

Since its inception in 2009, the BEACON Academy has not received any technological or equipment upgrades and minimal supplies. Upgrades for the BEACON Academy will be done with CTE allocated state and federal grant funds and span over 2-3 grant cycles. The table below indicates projected costs along with funding source for BEACON Academy.
